

NTI:bio Global Biosecurity Dialogue Purpose



What is the purpose of the GBD?

- Biosecurity remains **under-resourced and under-prioritized** within the global health security space.
- We are not using **common**, **measurable goals** to evaluate progress.
- There is **not enough collective action** a catalyst is required.

Going Forward We Propose:

- The Global Biosecurity Dialogue (GBD) will be a forum for enabling action.
- The GBD will leverage regional biosecurity experts to overcome barriers and inform development, prioritization, and tracking of biosecurity actions.
- NTI will convene the GBD once or twice per year each session will focus on one or more of the 3 proposed work-streams for the purpose of:
 - 1. Engaging new biosecurity partners/champions.
 - 2. Discussing specific barriers and creative solutions to national and regional biosecurity capability.
 - 3. Creating linkages between identified gaps and concrete actions to fill them.
 - 4. Enabling and tracking progress.

NTI:bio Work-streams Going Forward: Policy, Capability, Emerging Risks



Enabling and Tracking Progress

Summer 2018	Identify champions (volunteers); Create 3 work-streams for the Global Biosecurity Dialogue (policy, capability, risks).
Summer 2018	Work with attendees to further define new actions and barriers for each work-stream.
Summer-Fall 2018	Provide concrete recommendations to GHSA, GP.
Fall 2018	Announce and further discuss new planned actions during the GHSA Ministerial Meeting (Nov 2018) and the Global Partnership Working Group (Oct 2018).
Going Forward	Meet up to two times per year to:Develop creative solutions across 3 work-streams

Needs

Biosecurity and biosafety national policies (agreed & implemented)

Regional incentives and political will to prioritize biosecurity and biosafety (e.g. via ASEAN, Africa CDC) – narrative and communication

National Action Plans with concrete milestones for biosecurity and biosafety developed and annually tracked

Mechanisms for speeding time from assessment to financed plan: pairing assistance providers with National Action Planning process in real-time

Biosecurity/biosafety expert evaluators for JEE and National Action Plans

Agreement around emerging biological risks, including risks associated with advances in technology, and inclusion in existing evaluations and risk management frameworks

Policy Frameworks: Enabling Action



Identifying measurable steps toward passage and implementation of biosecurity legislation & policy instruments

Creating tools and opportunities for messaging about the importance of biosecurity policy frameworks, including by engaging parliamentarians & decision makers



Engaging funding agencies to improve incorporation of biosecurity considerations into support decisions

Formalizing defense engagement in international fora (e.g. GHSA) to increase adoption of policies encouraging mil-civ collaboration on health security

Capability Development: Enabling Action





Creating regional resource centers for developing biosecurity champions to advance and finance concrete, measurable, tracked milestones

Developing the next generation of biosecurity experts and bolstering biosafety & biosecurity associations



Establishing best practices on biosecurity and resource sharing, based on economic conditions, to improve sustainability, decrease risks



Improving biosecurity evaluator training and increasing expert involvement in JEEs




Assessing biosecurity-related skills of workforce and determine amount of time and resources needed to achieve desired level of competency

Emerging Risks: Enabling Action





Developing common indicators for national and regional efforts to identify and mitigate emerging biological risks

Conducting tabletop exercises to identify urgent risks and explore mitigation methods to guard against nefarious use

Engaging emerging biotech companies to develop new approaches for governance of dual-use research & risk mitigation

Analyzing impacts of disinformation campaigns on biosecurity and implementing mitigation measures
