NAP of the Republic of Tajikistan on the Implementation of UN Security Council Resolution 1540 # 54 from February 09, 2016, Governmental Decree №54 dated 9 February 2016 on UNSCR 1540 implementation in the country

- For implementation of its international obligations, the Government of the Republic of Tajikistan created a working group for development and harmonization of the normative-legal acts in accordance with requirements of the BTWC and the CPCW and UNSCR 1540.
- It includes representatives of all stakeholder ministries and state entities.
- The Working Group reviewed and analyzed legislation, according to the tasks of the project P 53, using questionnaires prepared by VERTIC experts.

Revision of Legislation

- The revision of laws and legal documents related to the BTWC, in accordance with the questionnaire, is completed;
- The analysis of gaps related to BTWC on legal instruments and laws has been carried out;
- Based on identified gaps and comments of international experts, measures will be taken to harmonize the regulatory framework in accordance with regulations of international conventions.

National measures on application of Alimentarius

The analysis of the Codex Alimentarius showed the absence of the following terminology in legislative documents, such as:

- Antimicrobial drug;
- Resistance to antibiotics;
- Pollutant;
- Critical control point;
- Equivalence;
- Primary production;
- Risk analysis;
- Risk management.

Analysis review of the National Measures on the Implementation of the International Health Regulations (2005) (IHR)

The analysis of national measures on the IHR is also completed in accordance with the list of legislative acts which are defined and there is a need for amendments and changes to be made:

Law of the Republic of Tajikistan on Biological Safety and Biological Security

- The purpose of this law is to implement the Convention on the Prohibition of Biological and Toxin Weapons and related provisions of United Nations Security Council Resolution 1540 by prohibiting the inappropriate use of controlled biological agents and toxins in any form, as well as improving biosafety and biosecurity, and facilitating the implementation of the Republic of Tajikistan its obligations to prevent the proliferation of weapons of mass destruction.
- Establishes bans on the improper use of controlled biological agents and toxins, as well as related offenses.
